1. Introduction

It is important that you read this guidance in full before you complete the Associate (Trainee) Membership and Pharmaceutical Medicine Application Form.

Before you decide to enrol on to the PMST programme, you should discuss this with your employer. You should also consider the following questions:

- Do you know why you want to enrol on to PMST?
- Do you have the time to commit to undertake the 4-year PMST programme?
- Do you work in a pharmaceutical organisation that will fully support you and give you the opportunity and time to complete at least three modules in the workplace (including the Interpersonal Management and Leadership Skills [IML] module)?

2. How do I enrol on to the PMST programme?

You must complete and return the forms listed below:

- a) Associate (Trainee) Membership and Pharmaceutical Medicine Specialty Training Application Form;
- a) Certificate of Professional and Clinical Competencies for Pharmaceutical Medicine (you might have to submit more than one completed Certificate);
- c) Individualised PMST Programme Form;
- d) Local Education Provider (LEP) Agreement (may not be necessary if you are working for a pharmaceutical organisation that is a GMC-approved LEP).

3. What do I need to do?

You must:

- a) be GMC registered with a licence to practise;
- b) be working in pharmaceutical medicine in the UK for a UK-based pharmaceutical organisation¹ that is a GMC-approved LEP;
- c) have completed at least 4 years of clinical training and/or experience;
- d) have an approved Educational Supervisor in pharmaceutical medicine.

If you are working for a pharmaceutical organisation that is not an approved LEP, you must first arrange for a Deanery Specialty Adviser to visit your organisation to assess its suitability to be approved as an LEP and to sign the organisation's LEP Agreement if they are satisfied that it will support your training. Once you receive confirmation from the Pharmaceutical Medicine Deanery ('the Deanery') that your pharmaceutical organisation has been approved by the GMC, you can submit your application to enrol on to PMST.

4. What evidence do I need to submit with my application form?

¹ A pharmaceutical organisation includes a pharmaceutical company, a clinical research organisation, a regulatory authority, an academic institution (if the unit or department you work in conducts research or studies that is relevant to pharmaceutical medicine) and a hospital (if the unit or department you work in conducts work that is relevant to pharmaceutical medicine).

The types of evidence you can use for your application to enrol on to PMST are listed in Table 1 below. Please be advised that this is not an exhaustive list.

The evidence must:

- a) support the clinical posts that you are relying for eligibility (i.e. completion of at least 4 years clinical training and/or experience) to enrol on to the PMST programme;
- b) demonstrate that you have achieved the professional and clinical competencies for enrolment on to PMST.

4.1 Doctors who completed UK-approved clinical training

Doctors who completed UK-approved training should include the following type of evidence of their professional and clinical competencies for eligibility to enrol on to PMST:

- a) UK Foundation Programme F1 and F2 ARCP outcome forms;
- b) UK core or specialty training ARCP outcome forms. Unsatisfactory outcomes (i.e. 2 and 3) and Outcome 4 (released from programme) must be included in submission;
- c) Foundation/core/specialty training workplace-based assessments, case- and/or project-based reflective practice;
- d) 360-degree multi-source feedback.

4.2 Doctors who completed approved overseas clinical training

Doctors who completed approved overseas clinical training should include the following type of evidence of their professional and clinical competencies for eligibility to enrol on to PMST:

- a) internship completion certificate(s), specialist or GP certificate(s);
- b) regulatory authority or royal college (e.g. Royal Australasian College of Physicians) letter confirming completion of approved overseas training;
- c) reference from employing hospital(s) commenting favourably upon your competence as a clinician.

4.3 Doctors who partially completed approved clinical training

Doctors who partially completed UK-approved clinical training, approved overseas clinical training or both, and gained the remainder of their clinical experience in non-training clinical posts before leaving clinical practice to work in pharmaceutical medicine, should include the following type of evidence of their professional and clinical competencies for eligibility to enrol on to PMST:

- UK Foundation Programme F1 and F2 ARCP outcome forms
- UK core or specialty training ARCP outcome forms. Unsatisfactory outcomes (i.e. 2 and 3) and Outcome 4 (released from programme) must be included in submission
- Foundation/core/specialty training workplace-based assessments, case- and/or project-based reflective practice;
- 360-degree multi-source feedback
- Internship completion certificate(s), specialist or GP certificate(s)
- Regulatory authority or royal college (e.g. Royal Australasian College of Physicians) letter confirming completion of approved overseas training
- Reference from employing hospital(s) commenting favourably upon your competence as a clinician.

4.4 Certificate of Professional and Clinical Competencies for Pharmaceutical Medicine

All pharmaceutical physicians applying to enrol on to PMST must have the Certificate of Professional and Clinical Competencies for Pharmaceutical Medicine completed by a Consultant, a GP supervisor or an Educational Supervisor in pharmaceutical medicine who can verify that the pharmaceutical physician has achieved the competencies to enrol on to PMST. At least **42 of the 52 listed competencies**, which must include all the key competencies, must be signed off. You may have to submit more than one Certificate.

You must ensure that the signatory completing the Certificate has access to the evidence of your competencies, whether that evidence is on the trainee e-portfolio you used during your clinical training or a paper-based portfolio.

7. Who will evaluate my application?

The FPM Specialty Training Manager will carry out a preliminary check of your application forms to make sure that the forms have been completed in full and that you have submitted the required documentary evidence. Your application will then be sent to a panel, composed of a member of the FPM's Deanery Executive Group and a manager from the Joint Royal Colleges of Physicians Training Board (JRCPTB), to evaluate and approve your enrolment on to PMST.

The evaluation panel will check the documentary evidence you have submitted to support the clinical posts that you are relying on for eligibility to enrol on to PMST and your completed Certificate(s) of Professional and Clinical Competencies for Pharmaceutical Medicine. The role of the evaluation panel is not to reassess your competencies, but to satisfy itself that you have achieved the competencies based on the verifications made by your former Consultant, GP supervisor or your prospective Educational Supervisor in pharmaceutical medicine.

The evaluation panel can ask you to clarify information you have entered on your application forms or evidence you have submitted before it decides the outcome of your application. The request for clarification can be made in writing or by email, by an arranged teleconference or with a face-to-face meeting.

8. Does it matter if I received an unsatisfactory ARCP outcome?

An unsatisfactory ARCP outcome will not normally disqualify an applicant from enrolling on to PMST if the unsatisfactory outcome was to extend the applicant's completion date to re-sit an examination or an assessment, or the applicant was released from their training programme and no training issues were recorded by the ARCP panel. However, each application will be evaluated on a case-by-case basis, and an applicant may still be asked for clarification about their unsatisfactory outcome.
