## FPM Chief Executive





This session explores the relationship between compliance

and ethics and the importance of both in sound decision-making. We will ask whether the current paradigm for generating, reviewing and approving commercialisation activities under the ABPI Code of Practice, is sufficient to meet the needs of patients and business and consider how a moral perspective on matters might change things. The aim of the session is to equip attendees with a practical approach to solving day-to-day problems that utilises both personal ethical intuition as well as an understanding of compliance obligations.

### 2 - Ethics and Trust in a Pandemic: ensuring ethical input alongside science and economics

This session will engage participants in aspects of the work and learning of the UK Pandemic Ethics Accelerator, which bought together ethics expertise to provide input into the key issues of the pandemic. Our focus will be 'trust' and 'trustworthiness' in pandemic health decision-making. After an opening discussion to help define and refine our key concepts, we

will introduce a set of case studies to invite discussion and reflection in smaller groups. We hope this will encourage understanding of how divergent moral intuitions, personal histories, social positions, and so forth can factor into the trustworthiness of urgent health decision-making, and trust in the actors making key decisions.

#### MEET THE SPEAKERS

#### **Professor Raanan Gillon**



Emeritus Professor of Medical Ethics at Imperial College London

Raanan is a hybrid of retired NHS GP and academic medical ethicist. He is Emeritus Professor of Medical Ethics at Imperial College London, where he still does a little teaching and continues to direct its five day intensive course in medical ethics, aimed primarily at practising doctors, which he started in 1983. He is past chairman and now honorary President of the Institute of Medical Ethics and a past President of the British Medical Association. He edited the Journal of Medical Ethics for 20 years, has published extensively on medical ethics and his elderly book 'Philosophical Medical Ethics' is in its 13th print. He enthusiastically advocates the 'four principles approach' to medical ethics.

#### Professor Ben Goldacre



Director of Bennett Institute for Applied Data Science

Ben is a doctor, academic, writer, and broadcaster. He trained in medicine at Oxford and UCL, in psychiatry at the Maudsley, and in epidemiology at LSHTM. His academic and policy work is in informatics, epidemiology and evidence based medicine, where

he works on various problems including variation in care, better uses of routinely collected electronic health data, evidence-based social policy, access to clinical trial data, efficient trial design, and retracted papers.

Ben runs the Bennett Institute for Applied Data Science. This is a multidisciplinary team of academics, clinicians and software developers, all pooling skills and knowledge to turn large datasets into tools and services as well as pure academic research papers.


